- The artist understands any submitted image may be used for publicity purposes, including, but not limited to posts in print, digital, and social media (Instagram, Facebook, Twitter, website etc.).
- The artist affirms that he/she has read the following documents [Standards for Presentation of Art Work in a SAWG Show](#) and [SAWG Show Policy](#) available on line at <https://southernazwatercolorguild.com/show-resources.php> and agrees to be bound by them.
- Signing this agreement and making your payment confirms that your painting(s) is (are) now submitted into this SAWG show. For any sales of painting(s) made from now until the show end date, SAWG will receive a 25% commission even if a customer goes directly to the artist for the sale. All sales must be processed through SAWG. For a **juried show**, if you receive notification that your painting was not accepted, your obligation ends that day.
- The artist understands that reasonable care will be taken for the safety of the work while on exhibit, and hereby releases SAWG and all members of SAWG from any and all claims of damage or loss of said work while in the possession of SAWG.
- The artist agrees to docent 2 shifts in compliance with the Show Policy or arrange for an acceptable substitute. Which may include a stipend of \$25 per show. See [Docent Substitute Policy](#) in Show Resources.
