For a **juried show**, if you receive notification that your painting was not accepted, your obligation ends that day.

- The artist understands that reasonable care will be taken for the safety of the work while on exhibit, and hereby releases SAWG and all members of SAWG from any and all claims of damage or loss of said work while in the possession of SAWG.
- The artist agrees to docent 2 shifts in compliance with the Show Policy or arrange for an acceptable substitute. Which may include a stipend of \$25 per day. See <u>Docent</u>
