**Show Exceptions:** *The first 200 paintings will be accepted. Extras may be held as replacements. Artists may enter 1-4 pieces. Everything must be priced UNDER \$300. Any 2D medium accepted, previously shown okay, no restrictions on date painted or mat color. Maximum size (glass, plexi, or canvas) is 16" X 20". Minimum size is 4" X 4". Art may be replaced by the artist when sold. If the artist chooses not to replace sold work, a painting by another artist on the waiting list may be substituted. Out of town artists are encouraged to leave work with someone here for the summer. This is a non-juried show, there will be no awards given except People's Choice.*

*Summer gallery hours will be 11-4:00. Two docent shifts of 5 hours each will be required.*

Entry forms, **postmarked by Fri., April 21 or received at the gallery by 5:00 PM Sunday, Apr. 23.**

No jpgs required. Entries will be acknowledged by email or phone.
